

MEMBERSHIP INFORMATION

The Federation of Bakers represents the major plant bakers in the UK, currently that comprises 9 member companies operating 34 bakeries nationwide manufacturing mainly sliced and wrapped bread. Our members produce the majority of the bread consumed in the UK with a market value of £3.5 billion per annum.

The Federation has two levels of membership; **Full Membership** and **Associate Membership**.

Full Membership of the Federation is open to any UK company manufacturing bread or bread and confectionery products.

Full member companies each get a seat and a vote on Federation Council, our decision-making body, and benefit from a range of key membership services:

Information and Consultation on a wide range of issues affecting the industry

Representation of members interests to Government and regulatory bodies

Interaction with members and other food industry representatives for exchange of information

Promotion of members' products and the nutritional benefits of bread as the nation's staple food

Value Added Services including;

- Director's Weekly Diary – a comprehensive round up of economic and industry news, key issues and events
- Key industry statistical data including annual bakery market update including bread production, sales, market trends and occupational health and accident rates.
- Updates on technical and legislative issues, industry research and special reports
- Health and safety initiatives including guidance covering baking industry specifics as well as more general health and safety guidance.
- Training resources including plant baking specific courses developed in conjunction with our excellent training partners at Thomas Danby College, Leeds and Campden BRI.
- PR and communications activities including joint PR programme with the Flour Advisory Bureau, press office and daily bread news
- Access to Members only web based data and a company profile and reciprocal website link
- Annual industry conference and members' networking dinner.

Subscriptions are based on weekly net turnover at a rate set annually by Federation Council, currently £17.15 per £1,000 weekly net turnover for 2018-19.
